Incident Summary:

The Cybersecurity and Infrastructure Security Agency (CISA) continues to monitor the evolving Coronavirus Disease, also known as COVID-19, situation closely. CISA is taking part in interagency and industry coordination calls and working with critical infrastructure partners to prepare for possible disruptions to critical infrastructure that may stem from widespread illness.

FEMA reports approximately 19,187,943 (+284,441 in the past 24 hours) cases and 716,075 (+6,565) deaths worldwide. In the U.S. there are approximately 4,974,959 (+54,590) cases and 161,284 (+1,064) deaths.

COMMERCIAL FACILITIES

(Outdoor Events)

The annual Sturgis Motorcycle Rally, a SEAR IV-rated event, is ongoing from 07 - 16 Aug in Sturgis, SD. It is expected to draw between 250,000 – 400,000 visitors, making it the largest public gathering since the pandemic began. The state and local government are urging personal responsibility and have not imposed any additional restrictions on the gathering. Regional personnel are monitoring and have reported no impacts to CI at this time.

GOVERNMENT FACILITIES

The FEMA Region 2 Watch Center and Regional Response Coordination Center (RRCC) have begun to conduct full remote operations on 09 Aug due to potential COVID 19 exposure and facility cleaning. The facility is anticipated to reopen for staff on 11 Aug at 1900 ET.

(Educational Facilities)

GA: At least 260 students and 8 teachers from the Cherokee County School District near Atlanta, GA, were quarantined after multiple students and teachers tested positive for the coronavirus during the first week of school.

NY: On 7 Aug, the Governor announced that schools across the state are permitted to open in the fall, based upon each state's infection rates being below the required threshold.

OH: The state ordered all students in grades K-12 to wear masks at public schools which have re-opened. The state and FEMA will distribute two million face masks to Ohio schools for use by staff and students.

HEALTHCARE AND PUBLIC HEALTH

As of 06 Aug, the Department of State, in coordination with the CDC, lifted the Global Level 4 Health Advisory. The initial advisory was put in place on 19 Mar and advised U.S. citizens to avoid all international travel due to the global impact of COVID-19.

The state of Arizona is coping with a surge in fatalities as cases have hit over 182,000. The medical examiner's office has hit 85 percent capacity and cooling units have been brought in to create space for other cases.

A senior state official in Maryland announced the seven-day average of the statewide COVID-19 positivity rate reached a new all-time low of 3.75 percent.

Ohio has become the latest state to record over 100,000 COVID-19 cases, according to its health department.

Health officials in Texas report the state's seven-day COVID-19 positivity rate has risen to 19.41 percent, the highest average since the pandemic began.

TRANSPORTATION SYSTEMS

(Aviation)

The Transportation Security Administration announced a \$2.5 million contract with Lavi Industries to build more than 1,200 acrylic barriers to be installed at 37 "priority" airports, which that are the TSA's busiest domestic hubs, as TSA workers continue to test positive for coronavirus.

ACTIVATIONS AND DECLARATIONS

ME: Maine extended its State of Civil Emergency for another 30 days. The new order expires on 03 Sep.

MI: The governor's office announced Friday the state is extending the emergency and disaster declaration until 04 Sep.

RI: On 05 Aug a senior state official announced anyone traveling into the state from 33 hot spots, including AZ, CA, FL, GA,, and TX will have to provide a negative COVID-19 test or must quarantine. The National Guard will assist with informing travelers of the tightened restrictions at airports.

Thirty-three states/territories have issued mandates for facial coverings; two states/territories have issued partial/regional mandates for facial coverings, but no state-wide mandates; fourteen states/territories have issued regional mandates for face coverings, but no state-side mandates; two states/territories have no mandates, and local orders are not enforceable; five states have no mandates.

Zero states/territories have complete stay-at-home orders in place. Four states have stay-at-home orders; however, only limited movement restrictions. Thirty-nine states and territories have lifted their stay-at-home orders, though may have other movement restrictions. Three states lifted state-wide orders, but maintain regional stay at home orders. Three states have not issued state-wide stay at home orders and have lifted all regional orders. Seven states and territories never enacted stay at home orders.

Seven states/territories require all visitors to quarantine. Twelve states/territories require visitors from designated hotspots to quarantine. Two states/territories have a regional quarantine order, but no state-wide quarantine order. Eight states/territories recommend, but do not mandate quarantine. Twenty-seven states/territories have no quarantine.
