Incident Summary:

The Cybersecurity and Infrastructure Security Agency (CISA) continues to monitor the evolving Coronavirus Disease, also known as COVID-19, situation closely. CISA is taking part in interagency and industry coordination calls and working with critical infrastructure partners to prepare for possible disruptions to critical infrastructure that may stem from widespread illness.

FEMA reports approximately 9,653,048(+659,389) cases and 491,128(+21,541) deaths worldwide. In the U.S. there are approximately 2,504,175(+167,560) cases and 125,484 (+4,367) deaths.

Key Points:

- FEMA deployed 2,520 (+19) employees in support of COVID-19 response
- 32,297,688 (+2,957,931) COVID-19 tests administered nationwide as of 27 JUN
- Connecticut and Rhode Island are the only two U.S. states reporting a decline in new coronavirus cases compared to last week

CRITICAL INFRASTRUCTURE IMPACTS:

GOVERNMENT FACILITIES

The U.S. Department of State authorized the voluntary departure of non-emergency U.S. personnel and family members from the U.S. Mission to Saudi Arabia, which is comprised of the Embassy in Riyadh and the Consulates General in Jeddah and Dhahran, due to the COVID-19 pandemic

HEALTHCARE AND PUBLIC HEALTH

The United States' National Institutes of Health (NIH) is set to open one of the largest coronavirus vaccine trials including 30,000 people in multiple countries, to test a government-created shot starting in July, followed about a month later with another 30,000 people expected to test a British one.

Florida health officials have reported 8,530 new coronavirus cases on 28 Jun. Florida now has 141,075 COVID-19 cases.

Officials in Kentucky, West Virginia, and Ohio issued warnings regarding outbreaks in their states linked to Myrtle Beach.

As coronavirus cases continue to surge in parts of California, the governor advised leaders in Imperial County to reinstate a stay-at-home order.

UT: On 25 JUN, the Governor approved requests from two counties to mandate mask-wearing in public spaces.

The National Bio-surveillance Integration Center (NBIC) announced that Virginia has become the first state to develop workplace safety rules to counter the COVID-19 pandemic. Employers will be forced to notify workers of possible exposure to infected co-workers within 24 hours of discovery.

Arizona Governor is allowing local jurisdictions to implement mitigation measures. COVID-19 models in Arizona indicate general hospital ward capacity could be reached in July/August if mitigation efforts are not implemented and COVID-19 trends continue uninterrupted.

CA: Butte County reports increased cases are overwhelming current contact tracing capacity and the County is unable to shift staff; State is not meeting the County's request for contact tracers.

Alaska remains in Phase 4 of reopening and has implemented testing for travelers arriving from out of state at airport, seaport, and road points of entry. Health Mandate 10 was updated to allow for shorter quarantine times for arriving travelers if negative COVID-19 testing can be proven.

TRANSPORTATION SYSTEMS

(Aviation)

United Airlines announced they are suspending service to Myrtle Beach International Airport in South Carolina due to the pandemic.

ACTIVATIONS AND DECLARATIONS

SC: Six states have issued warnings to residents about visiting Myrtle Beach as COVID-19 cases increase.

California ordered bars in seven counties, including Los Angeles, to close as the state and a dozen others face the worst surge in coronavirus cases since the start of the pandemic.

Washington announced 27 JUN, the state would hold off on moving to Phase 4, due to a rise of new cases.

Illinois moved into its next phase of its reopening plan on 26 JUN. The guidelines allow movie theaters, zoos, museums, and health and fitness centers to reopen with limited capacity. Restaurants will be able to offer indoor dining and gatherings of 50 people or fewer will be permitted. Schools and childcare programs with social distancing policies in place can also reopen.

NY: On 25 JUN, the NYC Mayor announced the city is on track to reach Phase 3 as soon as 6 JUL (allows indoor dining at 50 percent capacity and personal care businesses to reopen with restrictions).

Due to recent increases in COVID-19 cases, five states (DE, ID, LA, NM, and TX) have put their reopening plans on hold.

On 25 JUN, the Arkansas governor's office said the state is not ready to further ease restrictions on businesses as coronavirus cases continue to surge, while in Arkansas's capital, the Little Rock mayor's office ordered people to wear masks in public to prevent the virus's spread.

On 26 JUN, the Texas governor's office ordered the closure of all bars that get 51 percent of their gross receipts from alcohol, except for take-out, and the curbing of other business activity due to surging cases of the novel coronavirus in the state.

TX: Governor will pause any further reopening in response to increase in cases and hospitalizations; state does not intend to close any businesses that have already reopened; also suspending elective surgeries in multiple counties to ensure hospital bed availability to treat COVID-19 cases.

WA: Governor Inslee and Secretary of Health Wiesman announced a statewide order that will go in effect on 26 JUN requiring use of face coverings. The order requires individuals to wear a face covering in indoor public spaces such as stores, restaurants or offices, or when outdoors and unable to maintain 6 feet of separation.

Nevada delayed its transition to Phase 3 reopening until 30 JUN due to high positive case rates.

Zero states and territories have stay-at-home orders in place. Four states have stay at home orders; however, only limited movement restrictions. Forty states and territories have lifted their stay-at-home orders, though other movement restrictions may still apply. Two states lifted state-wide orders, but maintain regional stay at home orders. Three states have not issued state-wide stay at home orders and have lifted all regional orders. Seven states and territories never enacted stay at home orders.
